LOCATION

Arrow Point Retail Park is located approximately 2.5 miles north of the town centre, within the Harlescott regeneration area. Arrow Point occupies a prominent location fronting onto Brixton Way.

The town centre of Shrewsbury is easily accessible by excellent road connections. The Shrewsbury by-pass (A5125) to the north provides convenient access to the M54 Motorway, M6 Motorway and M6 Toll Road – linking Shrewsbury to Telford (15 miles), the West Midlands Conurbation (32 miles).

DEMOGRAPHICS

The County Town of Shrewsbury has a total residential population of approximately 95,000 persons (2001 census) rising to approximately 175,000 within a 12 mile radius of the town and a retail shopping population up to 150,000 (source CACI Ltd).
